



## **TONKAWA CASINO INTERNET PRIVACY POLICY**

### **I. APPLICATION OF THIS PRIVACY POLICY**

This Privacy Policy applies to all web sites owned or operated by Tonkawa Casino, including, but not limited to, the web sites for: Tonkawa Casino ([www.tonkawacasino.com](http://www.tonkawacasino.com)); [www.360wichita.com/Entertainment/TonkawaCasino.html](http://www.360wichita.com/Entertainment/TonkawaCasino.html); Tonkawa Casino web sites may be accessed through domain names in addition to the domain names listed above. This Privacy Policy does not apply to information collected by Tonkawa Casino by means other than through the Tonkawa Casino web sites.

Certain transactions and services offered while visiting Tonkawa Casino web sites may be processed or provided by other entities under contract with Tonkawa Casino, even though it appears that you may not have left the Tonkawa Casino web site. This Privacy Policy does not apply to information collected by other entities; except that Tonkawa Casino will treat information it receives about you from other entities under the terms of this Privacy Policy. To determine the privacy policy applicable to information collected by these other entities, please consult the web sites of the other entities.

### **II. INFORMATION WE COLLECT ABOUT YOU**

#### **General Information**

When you use the Internet, your web browser or client software may transmit certain information to the servers that host the web sites you visit. The information may include the unique number assigned to your server or Internet connection, the capabilities and features of your computer, your geographic location, and your movement within and interaction with the web site, including what pages you look at and what information you download. When you visit Tonkawa Casino web sites, the Tonkawa Casino servers collect such information. The Tonkawa Casino uses this information to generate aggregate statistics about visitors to its web sites.

#### **Personally Identifying Information**

The Tonkawa Casino only collects personal information that you voluntarily provide to us or voluntarily provide to other entities who share that information with us. "Personal Information" is information through which you can be identified. The Personal Information that Tonkawa Casino collects through its web sites or obtains from its other entities depends on the nature of your online activity. Personal information that the Tonkawa Casino may collect from you directly or through other entities, includes your name, address, e-mail address, telephone number(s), fax number, birth date, gender, credit card information, purchase and reservation information and other information that you voluntarily provide. The personal information is collected by e-mail, through online forms, and through your activities on the Tonkawa Casino web sites.

### **III. HOW WE USE THE INFORMATION WE COLLECT**

The Tonkawa Casino may use the information collected by us or other entities: (1) for marketing purposes, including, but not limited to, notifying you of special promotions, offers and events at

any of our properties; (2) to process and fulfill reservations; (3) to enable us to contact you for confirmation or customer service after reservations and purchases are made or after you sign up for or participate in certain activities; (4) to respond to inquiries, complaints and other communications; (5) to cross-reference with other personal information that we have acquired about you or may acquire about you through other sources; and (6) for profiling or demographic purposes.

#### **IV. DISCLOSURE OF INFORMATION WE COLLECT**

Except as provided below, Tonkawa Casino will not sell, trade, or disclose to third parties any personal information obtained through its web sites or obtained from other entities, without your consent. The Tonkawa Casino may disclose Personal Information: (1) to comply with a court order, subpoena, search warrant or other legal process; (2) to comply with legal, regulatory or administrative requirements of any governmental authorities; (3) to protect and defend Tonkawa Casino, the Tonkawa Tribe of Indians of Oklahoma, their affiliates, and all of their officers, directors, employees, attorneys, agents, contractors, and partners, in connection with any legal action, claim or dispute; (4) to enforce the terms of use of Tonkawa Casino web sites; (5) to prevent imminent physical harm; (6) to businesses that Tonkawa Casino may use for purposes of performing functions on behalf of the Tonkawa Casino, such as companies that process credit card transactions; and (7) in connection with the sale, assignment, or transfer of any Tonkawa Casino property or Tonkawa Casino web site.

#### **V. CHOICE REGARDING PROVIDING INFORMATION**

General information is collected whenever you browse the Tonkawa Casino web sites. The Tonkawa Casino web sites do not provide any means for opting out of providing general information when you browse its web sites. An example of general information would be noting the domain name of the web site from which you linked to our site or advertisement.

You can browse the Tonkawa Casino web sites without providing any personal information. However, providing personal information is required to use some of the services offered through the web sites, including, but not limited to, making hotel reservations, making purchases, requesting information and participating in sweepstakes.

#### **VI. CHANGING PERSONAL INFORMATION OR OPTING OUT**

You can opt out of receiving certain communications and offers. Opt out options will be indicated when they are available. #### **VII. ACCESS**

The general or personal information collected through the Tonkawa Casino web sites or provided by other entities is not currently accessible to you, except that confirmation is provided for some transactions and services, such as reservations and purchases.

#### **VII. SECURITY**

General information and personal information collected by Tonkawa Casino web sites is stored on secure servers. The secure servers are protected by firewalls and other standard security procedures. The secure servers are not generally accessible by unauthorized third parties, but could become accessible in the event of a security breach. Third party Internet sites and services accessible through Tonkawa Casino web sites have separate privacy and data collection practices, independent of us. The Tonkawa Casino has no responsibility or liability for these independent policies or actions. You are solely responsible for maintaining the secrecy of your passwords or any account information. Please be careful and responsible whenever you're online. If you post personal information online that is accessible to the public, you may receive unsolicited messages from other parties in return. While we strive to protect your personal

information, Tonkawa Casino cannot ensure or warrant the security of any information you transmit to us, and you do so at your own risk.

#### **VIII. AGE RESTRICTIONS AND THE CHILDREN'S ONLINE PRIVACY PROTECTION ACT**

Pursuant to law, persons under the age of eighteen (18) are not permitted within the Tonkawa Casino. Similarly, Tonkawa Casino web sites are general audience sites intended for persons over the age of 18. In accordance with the Children's Online Privacy Act, person younger than 18 years of age are not allowed to use our site, accept offers, or win contests, and we do not knowingly collect information from such persons.
